AGREEMENT WITH JASON SAXBY ENTERPRISES

Trading as Accredited Professional Feral Eradication Hunting Safaris (A.P.F.E)

The following document is an agreement between the CLIENT and JASON SAXBY ENTERPRISES trading as Accredited Professional Feral Eradication Hunting Safaris (A.P.F.E.) This document outlines the terms and conditions of a hunt with APFE, and binds the Client to follow those terms and conditions.

This document also contains an 'limitation of liability and indemnity' clause making APFE and Property Owner not liable for any loss, injury or damage sustained by the client or any other persons or property and whether directly or indirectly from the sale or use of any products, goods or services and indemnifying APFE against any claim, demand or Proceedings made or brought arising from such loss, injury or damage. Nothing in this Agreement purports to modify or exclude any liability, which may not be excluded or modified under the Trades Practices Act 1974 (Cth.).

TERMS AND CONDITIONS

THE CLIENT AGREES TO BE BOUND TO THE FOLLOWING TERMS AND CONDITIONS:

HUNTING REQUIREMENTS FOR CLIENTS

- Shooters must be licensed.
- Minors must have 'Minors permit' and be accompanied by parent/s or guardian/s who themselves must be licensed for firearms.
- Overseas clients are required to purchase a firearms permit for Aust\$25.00 from the Australian Firearms Registry before undertaking a Safari.
- All dogs must be registered.
- Client's dog(s) are to be restrained at all times when not hunting.
- When hunting with dogs, clients are permitted to hunt pigs only.
- Without dogs, clients can hunt pigs, goats, foxes, hares, rabbits and feral cats.
- Clients per hunting party: minimum one (1), maximum of three (3) to one (1) guide or maximum four (4) to two (2) guides.
- Clients are fully responsible for their own actions and for the actions of their animals whilst on the property.
If clients are using dogs to hunt with the animal must be on a lead or in a dog crate when hunting until a pig is either spotted by a guide or bailed by an APFE dog.
- Clients are only allowed two (2) dogs per person when in a hunting party of one (1) or two (2).
- Hunting party/parties of three (3) and four (4) are allowed to use only one dog per person.

WHILST STAYING ON PROPERTY

- Safe keeping of firearms is to be in lockable steel containers provided by APFE whilst not hunting at all times.
- Sighting of rifles is to be within the designated area of the property.
- When hunting, shooting is to be done at least 1km away from homestead, unless permitted by guide.
- Clients are not permitted to shoot towards the homestead or quarters at anytime.
- Clients are not permitted to shoot if another person is within a 5mtr radius of them.
- Clients are not permitted to shoot without ear protection at anytime.
- Clients are not permitted to shoot until game is identified.
- ONLY ONE DESIGNATED SHOOTER when hunting from vehicle. ALL other FIREARMS are to be FULLY UNLOADED AT ALL TIMES!
- CLIENTS MUST ONLY FIRE FIREARMS DIRECTLY IN FRONT OF THEMSELVES whilst hunting in a group. The same direction the group is walking.
- CLIENTS MUST NEVER go through, under or over a fence/

closed gate with a FULLY armed firearm.

The firearm must be FULLY unloaded (if by yourself lay firearm on the ground) if accompanied pass firearm Safely (SAFETY TRIGGER MUST BE ON) over fence.

- Where APFE and/or property equipment and/or stock is damaged or destroyed by the client/s or client/s dog/s, the client/s are to pay for or replace the equipment and/or stock to the full purchase price.
- Camping grounds and Quarters will be completely cleaned, all rubbish of the client is to be removed and disposed of properly at the designated property tip.
- The client is obligated to leave the property in the way they found it.

COSTS

- A deposit of 20% is to be paid on client booking.
- The client is to pay the balance at least two weeks prior to commencing the safari or the safari will be cancelled and the balance paid by the client fully refunded
- APFE equipment is available for hire; all equipment is to be paid for prior to usage.
- RAIN: In the event of rain out, the safari will not be cancelled nor money refunded; instead the safari will be postponed and rescheduled for a future date as agreed to between APFE and the client.
- Jason Saxby Enterprises trading, as APFE will not be liable for any rain out of a safari conducted in black soil country/ otherwise any rain out of a safari.
- In the event of not being able to attend safari on booked dates, due to personal or work commitments.
Safari will not be cancelled nor money refunded; instead safari will be postponed and rescheduled for a future date as agreed to between APFE and the client.

LIMITATION OF LIABILITY AND INDEMNITY

- Neither Jason Saxby Enterprises nor the Property Owner will not be liable for any loss, injury or damage (including, without limitation, loss of profit, consequential or economical loss) sustained by the client or any other person or property and whether directly or indirectly from the sale or use of any product, goods or services.
- The client will indemnify Jason Saxby Enterprises and Property Owner, and keep Jason Saxby Enterprises and Property Owner indemnified against any claim, demand or proceedings made or brought arising from such loss, injury or damage.
- Jason Saxby Enterprises trading, as APFE will not be liable for any rain out of a safari conducted. In the event of such a rain out, the safari will not be cancelled, nor will money be refunded; instead the safari will be postponed and rescheduled for a future date as agreed to between APFE and the client.
- IMPORTANT NOTICE: nothing in this Agreement purports to modify or exclude any liability, which may not be excluded or modified under the Trades Practices Act 1974 (Cth).
- The proper law of this Agreement is the law of NEW SOUTH WALES and the parties submit to the non-exclusive jurisdiction of the courts of the state.
